Division of Community Advancement and Leadership Strategies (D-CALS)

D-CALS provides capacity building assistance (CBA) to improve the ability of community-based organizations (CBOs), health departments (HDs), and prevention planning groups (PPGs) to operate optimally and become sustainable entities to reduce the burden of HIV infection in the United States. Guided by an individualized assessment of resources and needs, D-CALS creates a specialized action plan for organizations approved to receive services.

For PPGs, services promote effective communication with HDs to successfully develop comprehensive HIV prevention plans based on the latest guidelines, scientific evidence and community needs as well as developing and enhancing collective knowledge and skills essential to PPGs.



Minority Serving Institutions HIV/AIDS Initiative

The Minority Serving Institutions (MSI) HIV/ AIDS Demonstration is sponsored by the Department of Health and Human Services Office of HIV/AIDS Policy



(OHAP) and was designed to stimulate innovative and sustainable HIV prevention programs on MSI campuses. NMAC provides technical assistance and support to the seven institutions chosen to participate in this initiative.

Division of Conferences and Meeting Services (CMS)

NMAC develops and facilitates various national conferences and meetings that bring together the most prominent leaders in the HIV/AIDS community to provide invaluable education and training.

United States Conference on AIDS (USCA)

CMS develops, organizes and implements the U.S. Conference on AIDS (USCA), the largest annual AIDS-related gathering in the country. Thousands of workers representing all fronts of the HIV/AIDS epidemic—from case managers and physicians, to public health workers and advocates, people living with HIV/AIDS (PLWHAs) and policymakers—come together to build national support networks, exchange the latest information and learn cuttingedge tools to end this epidemic.

Treatment Education, Adherence and Mobilization (TEAM):

TEAM's mission is to contain, if not eliminate the transmission of HIV indefinitely by promoting leadership and enabling communities of color to access HIV counseling & testing services, treatment and quality health care. The program aims to provide the tools needed to contain new HIV infections and related comorbidities.



Division of Legislative and Public Affairs (LPA)

NMAC's Legislative and Public Affairs (LPA) Division heads the agency's advocacy efforts, promoting sound national healthcare policy with a focus on issues related to HIV/AIDS, access to care and social justice as they impact communities of color. The Division manages NMAC's public policy development and advocacy, grassroots education, communications and outreach and community mobilization efforts.
